**MOTION FOR LEAVE TO FILE SUPPLEMENTAL BRIEF
EXCEEDING PAGE LIMITS**

Pursuant to Local Rule 7(h), Plaintiff Continental Western Insurance Company (“Plaintiff”) respectfully moves for leave to file a supplemental brief 24 pages in length concerning the recent district court decision in *Perry Capital, LLC v. Lew*, No. 13-1025 (D.D.C. Sept. 30, 2014), Doc. 51. On October 6, the Defendants in this action filed a notice of supplemental authority urging the Court “to take [the *Perry* decision] into account when considering the issues presented by the motions to dismiss pending here.” Defendants’ Notice of Supplemental Authority at 2, Doc. 48. Plaintiff submits this brief to address the relevance of the district court’s decision in *Perry* to the disputed issues raised by Defendants’ motions to dismiss. Good cause exists for this motion because the parties have had no previous opportunity to address the complex issues raised by the *Perry* decision in their briefing. Defendants have authorized Plaintiffs to represent that Defendants take no position on this motion but request an

opportunity to file a response of equal length if Plaintiff's motion is granted. Plaintiff of course consents to that request.
